ENVIRONMENTAL AND SOCIAL COMMITMENT PLAN

- 1. The Republic of Nicaragua (hereinafter the **Recipient**), is implementing the Hurricanes Eta and Iota Emergency Response Project (the **Project**), with the involvement of the Ministry of Finance and Public Credit (MHCP), with the assistance of the United Nations Office for Project Services (UNOPS), and in coordination with Relevant Sectoral Entities, as set out in the Financing Agreement for the original financing and the Grant Agreement for the Additional Financing. The International Development Association (hereinafter **the Association**), on its own behalf, agreed to provide the original financing (P175878), and acting as administrator of the Global Agriculture and Food Security Program (GAFSP), has agreed to provide additional financing (P181157) for the Project, as set out in the referred agreements. This ESCP supersedes previous versions of the ESCP for the Project and shall apply both to the original and the additional financing for the Project referred to above.
- 2. The Recipient shall ensure that the Project is carried out in accordance with the Environmental and Social Standards (ESSs) and this Environmental and Social Commitment Plan (ESCP) in a manner acceptable to the Association. The ESCP is a part of the Financing Agreement and the Grant Agreement. Unless otherwise defined in this ESCP, capitalized terms used in this ESCP have the meanings ascribed to them in the referred agreement(s).
- 3. The Recipient is responsible for compliance with all requirements of the ESCP even when implementation of specific measures and actions is conducted by UNOPS, or any other entity as indicated by MHCP.
- 4. Without limitation to the foregoing, this ESCP sets out material measures and actions that the Recipient shall carry out or cause to be carried out, including, as applicable, the timeframes of the actions and measures, institutional, staffing, training, monitoring, and reporting arrangements, and grievance management. The ESCP also sets out the environmental and social (E&S) instruments that shall be adopted and implemented under the Project, all of which shall be subject to prior consultation and disclosure, consistent with the ESS, and in form and substance, and in a manner acceptable to the Association. Once adopted, said E&S instruments may be revised from time to time with prior written agreement by the Association.
- 5. As agreed by the Association and the Recipient, this ESCP may be revised from time to time if necessary, during Project implementation, to reflect adaptive management of Project changes and unforeseen circumstances or in response to Project performance. In such circumstances, the Recipient shall agree to these changes through an exchange of letters signed between the Association and the Recipient, represented by the Viceminister of the MHCP. The Recipient shall promptly disclose the updated ESCP.
